Subject:- Filling up of the post of Section Officer in the Headquarters and Regional Offices of Narcotics Control Bureau, Ministry of Home Affairs on deputation basis including short-term contract: Reg.

Narcotics Control Bureau, Ministry of Home Affairs intends to fill up **05** (five) existing vacant posts of Section Officer on deputation basis including short-term contract [ISTC]. The vacancies may vary (increase/decrease). The selected candidates are liable to be posted anywhere in the country in any of the Regional Offices/Headquarters of Narcotics Control Bureau. Any conditional application regarding place of posting or any other issue shall not be entertained.

- 2. The post of Section Officer carries the pay in Level-7 of the Pay Matrix Rs.44900-142400/-.
- 3. The Recruitment Rules notified in the Gazette of India vide GSR No.930(E) dated 03.12.2015 for the post provide for 100% to be filled up by promotion failing which by deputation including short-term contract. Required number of officers of the reserved category in the feeder grade are not eligible for promotion in Narcotics Control Bureau. Hence, 03 posts will be filled up on deputation basis including short-term contract under failing which clause.
- 4. The terms and conditions of the deputation will be governed by the Department of Personnel & Training's OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time.
- 5. The Recruitment Rules for the post of Section Officer in the Narcotics Control Bureau provide for deputation including short-term contract of officers of the Central Government or State Governments or Union Territories or Autonomous Bodies or Public Sector Undertaking or statutory bodies or recognized research institutions or Universities or semi-government organizations:
 - (a) (i) holding analogous posts on regular basis in the parent cadre or department;
 - (ii) with five years service in the grade rendered after appointment thereto on regular basis in the pay band-2, Rs.9300-34800 with grade pay of Rs.4200/-, or equivalent in the parent cadre or department; and

- b) possessing the following educational qualification and experience:
 - (i) Bachelor's degree from any of the Universities incorporated by an Act of Parliament or State Legislature or other educational institutions established by an Act of Parliament or declared to be a deemed University under the University Grant Commission Act, 1956; and
 - (ii) Two years work experience in accounts or administration or establishment matters.

Duties of the Section Officer:

- (i) Supervision of ministerial work of respective Section.
- (ii) Guidance to Staff.
- (iii) Time bound action on receipts
- (iv) Co-ordination between different offices in Ministerial works.
- (v) Looking after the welfare of Staff members etc.
- (vi) Liaison with offices & Ministry for pursuing various issues.
- (vii) Any other work assigned by the superior officer.
- 6. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed 03 (three) years.
- 7. The age limit for appointment by transfer on deputation shall be not exceeding 56 (fifty six) years on the closing date of receipt of applications.
- 8. For the purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2016 or the date from which the revised pay structure based on the Seventh Central Pay Commission recommendations has been extended or shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission, except where there has been merger of more than one pre-revised scale of pay into one grade pay or pay scale and where this benefit will extend only for the post or posts for which that grade pay or pay scale is the normal replacement grade without any up-gradation.
- 9. The vacancy circular may be brought to the notice of eligible officers of your cadre/department. The application of eligible and willing officers who can be spared at short notice in the event of their selection may be obtained in the revised Bio-data/C.V. proforma, in original, [format attached] and be forwarded to the Dy Director General (P&A), Narcotics Control Bureau Headquarters, 2nd Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110 066 along with following requisite documents so as to reach this Bureau within 60 days from the date of issue of this circular:
 - i) Supporting certificate/documents in respect of claimed educational qualification including essential qualification of Bachelor Degree (duly attested).

- Photo copies of APARs for the last five years duly attested (with stamp) on ii) each page by an officer not below the rank of Under Secretary to the Government of India or equivalent, including GAP Sheet/NIC/NRC. In case, NRC is not issued, an undertaking may be provided by the Employer's/Cadre Controlling Authority with the valid reasons.
- (iii **Integrity Certificate**
- Vigilance Clearance certificate as per proforma iv)
- Major/minor penalty statement for the last 10 years and v)
- Cadre clearance incorporating that in the event of his/her selection, he/she will vi) be relieved to join the post of Section Officer in NCB on deputation basis.
- The applications received after the closing date and conditional application shall not be entertained. It may noted that in the event of their selection, the candidates will not be allowed to withdraw their candidature.
- 11. All applications must be routed through proper channel. No advance application will be entertained.
